

WHUD TAP & CAPACITY FEES

If a water main is currently in place at the location service is requested and no additional meters larger than 1" are required, the following water fees apply:

5/8 x 3/4" Water	\$2,000 + \$50 New Account Setup Fee	WHUD provides meter & all materials, installs meter, and makes the tap.
5/8 x 3/4" Irrigation (Residential).....	\$1,200 + \$50 New Account Setup Fee	WHUD provides meter & all materials, installs meter, and makes the tap. Reduced irrigation tap fee is available only in addition to the purchase of the domestic water meter listed above. Additional costs to the homeowner will include a backflow prevention device and contracting with a plumber for its installation.
5/8 x 3/4" Irrigation (Commercial)	\$2,000 + \$50 New Account Setup Fee	WHUD provides meter & all materials, installs meter, and makes the tap.
1" Water.....	\$2,800 + \$50 New Account Setup Fee	WHUD provides meter & all materials, installs meter, and makes the tap. Additional costs to the homeowner of a 1" tap used for a residential fire sprinkler system will include a backflow prevention device and contracting with a plumber for its installation.

If a water main extension is required to provide access to water service or if your project requires any water taps larger than 1", the following capacity fees based upon meter diameter apply. The contractor must provide all labor, materials, and meters per WHUD specifications and use a WHUD pre-approved tapping contractor to tap the water main.

5/8 x 3/4" Capacity Fee	\$2,000 + \$50 New Account Setup Fee
1" Capacity Fee.....	\$2,800 + \$50 New Account Setup Fee
2" Capacity Fee	\$4,000 + \$50 New Account Setup Fee
4" Capacity Fee.....	\$7,000 + \$50 New Account Setup Fee
6" Capacity Fee.....	\$10,200 + \$50 New Account Setup Fee
8" Capacity Fee.....	\$13,600 + \$50 New Account Setup Fee

Sewer Capacity Fee..... \$2,700 for each equivalent residential connection. Please contact WHUD's Engineering Dept. at 615-672-4110 x241 to obtain detailed information about connecting to our sewer mains and to find out if there are any additional costs to be incurred by the customer.

Retail, Commercial, and Multifamily fees will be calculated on a individual basis. Please contact WHUD's Engineering Dept. to find out the process for determining these fees.

*The customer is responsible for the connection from the water or sewer tap to the home or business.

*All irrigation taps and all commercial taps require backflow prevention assemblies. For more information on backflow prevention requirements call 672-4110 x457.
